

ATTENTION:

All Potential Participants of *Winter Wishes 2008* Auditions:

Auditions are tentatively scheduled for July 26, 2008 from 2pm – 7pm. Any change will be posted at EPIC. Late applications will incur an extra fee, and due to time restraints, may not be accepted.

ELIGIBILITY TO AUDITION:

- Skaters must be home club members of the ISCFC in good standing of the ISCFC. Skaters who are not members of the ISCFC by the deadline of July 12, 2008 will not be allowed to audition. No exceptions.
- Skaters must be taking regularly scheduled lessons with an EPIC coach in the calendar year (Starting Jan 1, 2008) in which they are auditioning. “Regularly scheduled” is defined by a consistent weekly lesson time. Coaches will be asked to sign the audition applications attesting that the lessons have been given and payment has been received.

DESIGNATED LEVELS:

- Skaters are required to have tested at, or have skated a program to music at a competition, prior to the auditions, at the level that they are registering, in the calendar year they are auditioning (starting Jan 1, 2008).
- Those skaters testing at PrePreliminary in August are not eligible to audition for a featured part in *Winter Wishes 2008* and will be cast with skaters that also have not tested PrePre Freeskate Test by July 26, 2008.
- Skaters who compete at Vail 2008 may elect to use the level in which they competed at in Vail for their audition level. The level for auditions must be declared to Christine no later than July 21, 2008.
- “Spins, jumps, compulsory, or moves” programs are not eligible programs to designate a level for auditions. Only short programs, free skate programs, and artistic programs are to be used for a designated level for auditions. Program length cannot exceed competition requirement for the level entered for the type of program chosen.

- Skaters are required to register for auditions at the level they entered the competition. If a skater is “bumped up” at a competition to be combined with a higher level, the skater must still register to audition at the level they originally entered the competition.
- Duets, trios and group numbers will not be levels that are offered for auditions. Due to the time restraints of the auditions and the show, it is not possible to offer these levels as audition opportunities. Pairs will follow the same requirements as singles. Dance teams will be automatically placed in a dance production number, if there is one.

VIDEOS:

- If a skater cannot make the audition, 2 video filming days will be offered at the beginning in June. Videos submitted must be of performances of a program to music at a competition/test level that they are registering for in the calendar year they are auditioning. Winter Wishes 2007 videos are acceptable. Videos must be submitted by the deadline prior to the auditions. No late videos will be added to the auditions except in cases of acute injury or sudden illness.

GENERAL:

- If the skater’s application for auditions is found to be incorrect, the skater will be informed of the discrepancy, and placed in the correct level. If the discrepancy is not discovered until after auditions, the correction will be made during casting.
- 2008 membership fees due to join the ISCFC—July 1, 2008.
- Deadline to sign up for auditions and/or submit a video—July 12, 2007, 5:00pm.
- The level for auditions must be declared to Christine no later than July 21, 2008.
